

Rules and Regulations

Contest Name: Lite 93.5 Golf Tour

Age requirements: Must be at least 18 years old to participate.

Contest begins: Tuesday, June 5th, 2007

Contest ends: Tuesday, September 4, 2007

Golf Tour prize(s): Each week, one lucky golfer will win a special Lite 93.5 WSBG prize-pack, items to be determined.

Golf Tour Grand Prize: The \$100,000 is an insurance-based contest provided by Million Dollar Media. The \$100,000 is a lump sum cash payout. In the event of a winner, Million Dollar Media will pay the winner. The winner of the \$100,000 will also be issued a 1099.

How to win: Each golfer participating in the Lite 93.5 Golf Tour (here by referred to as "L935GT") should complete an entry blank at the participating golf course of the week. One random winner per week will be selected from all entries received. This winner will then automatically qualify for the L935GT Grand Prize finale at Shawnee Inn & Golf Resort on Tuesday September 18th, 2007. During this finale, qualifiers will play a complimentary 18 hole round of golf. After that round of golf all qualifiers will be invited to shoot for the hole-in-one at Tillinghaust Golf Academy.
