## 16 Month Panama City Beach Girls Calendar Promotion: General Concept

The following is a combined effort between Borderline Graphics (B-GFX) and the Panama City Radio Group (PCRG) in an effort to create a calendar that promotes all of the stations of PCRG including Arrow 95.9, HANK FM 103.5, BOB FM 105.1, and PFM 107.9, all of their participating sponsors, Borderline Graphics and the March of Dimes. The calendar will be sold at the station headquarters, online on all four stations websites, any applicable social networking sites of the stations, and a soon to be named ancillary site promoting the calendars. A portion of the proceeds will go directly to the The March of Dimes and will presented at a press conference at the completion of the promotion sometime in August or September 2010.

Beginning Thursday March 11, 2010 the radio stations will be requesting models and aspiring models to submit their photos to the stations for a chance to be chosen as one of the 16 ladies to appear on the Panama City Radio 2010-2011 16 Month Swimsuit Calendar. Model submissions will be accepted until April 1, 2010.

## Online Model Photo Submissions & Voting Process

Models from around the area - no more than 60 miles from Panama City/Panama City Beach, Florida - are to submit a photo of themselves in a bathing suit, bikini or other outfit to the radio stations via the email address [calendergirl@panamacityradio.com](mailto:calendergirl@panamacityradio.com). The approved photos will be posted on the website of each of the four stations of the PCRG to begin the online voting process. The photo must be tasteful, must not contain any nudity, and must show the models face.

After an image has been submitted, all participants must fill out a model release form and must guarantee that they are 18 or older to be considered.

Once the image has been received and approved by either members of PCRG or B-GFX the image is posted in the Calendar Girls Model Gallery and voting begins on March 18, 2010. Model Benefits & Individual Promotion

Each model chosen will receive a professional photo shoot complete with professional hair styling and makeup valued at over \$500, 3 copies of the calendar for her personal portfolio, a disc of the top 12 images from her modeling shoot, as well the capability to promote her personal modeling portfolio to a listening audience of the Panama City Radio Group for the summer season.

Models are required to be available for the launch party (date to be assigned) as well as additional promotional opportunities via the radio station (remotes, celebrity appearances, interviews, etc..) Failure to comply in some circumstances could be removal of the program. B-GFX has prepared the initial Model Releases, a Rules & Waiver Agreement, and Individual Shoot Schedule which are included with this document.

## Calendar Model Promotional Participation Rules & Waiver

All models/participants are expected to maintain a professional appearance and positive attitude at all times. As a representative of Panama City Radio Group, Borderline Graphics and all of the participating sponsors, all improprieties listed below are grounds for immediate dismissal and removal from the program. If at any time, the reputation of any or all of the participating parties could be spoiled by a model's actions, statements or behavior, there will be an immediate termination of this agreement and the model will forgo any benefits afforded by participation in the program and may be liable for damages real or implied.

### Calendar Girls Will Not Under Any Circumstance:

- Consume, possess, or be under the influence of alcohol before or during any scheduled appearances
- Consume, possess, or be under the influence of illegal drugs before or during any scheduled appearances
- Remove partially or completely any clothing during a scheduled appearance. There will be no public nudity or partial nudity of any kind.
- Discussion any negative views or opinions of the participating parties and or sponsors is strictly prohibited
- Spouses/Partners must not interfere during any scheduled appearances. Chaperones are allowed to be on site but must stay clear of all activities and promotions while they are taking place. Repeated interference by said party is grounds for dismissal.
- If at any time a model has broken any state of federal law in any way, all controlling parties will participate fully with any and all law organizations to ensure that law breakers will be punished to the fullest extent of the law.
