1	Internship Program	<p>During this reporting period, this SEU hosted nineteen (19) student interns, six (6) in the Fall, nine (9) in the Spring and nine (9) in the Summer. These students, from the University of Illinois-Champaign and Parkland College, expanded their knowledge about broadcasting by obtaining hands-on experience in a broadcast environment. The interns began their internships under the tutelage of this SEU's Promotions Director. Depending on their particular interests, however, we allow them to explore different aspects of the business. For example, some learned to operate studio equipment and assist with remote broadcasts, some worked in the sales arena and assisted with the development of sales materials. All interns were rewarded with course credit hours upon completion of the semester-long program.</p>
2	Training	<p>On June 15, 2011, Sales manager and sales team attended an Illinois Broadcasters Association sponsored seminar in Bloomington, Illinois. Subject matter covered, general sales trends, emerging technology, and provided staff with a venue to share employment opportunities.
