EEO OUTREACH ACTIVITIES

February 1, 2010 – February 1, 2011

Roser Communications Network, Inc. has set up a comprehensive outreach and recruitment program and an EEO self-assessment program designed to widely disseminate information regarding full-time job opportunities at its stations and to ensure the compliance of the unit with the FCC's EEO rules.

Every six months, all Roser Communications Network, Inc. stations air a Public Notice Press Release inviting community groups, minority organizations and interested civic organizations to notify station management if their group would like to be notified regarding each new, full-time job opening. Roser Communications Network, Inc. also sends these same press releases, annually, to community groups, minority organizations and interested civic organizations seeking the involvement of local groups as part of the licensee's recruitment efforts. To date, one local group has expressed interest in receiving information regarding any job openings. The licensee plans to continue its advertising efforts with the hope that local groups might soon be interested in receiving such information.

Roser Communications Network, Inc. advertises all of its job openings on the air over each of its broadcast stations and, where appropriate, in the local newspapers, Utica Observer Dispatch and The Johnstown Gazette.

Roser Communications Network, Inc. has selected the following menu options as a result of self-assessment of its EEO program:

Host One Job Fair every year.

Participate in other activities than the ones listed that the licensee has designed to further the goal of disseminating information about employment opportunities.

Provide training to management level personnel as to methods of ensuring equal employment opportunity and preventing discrimination.

2010-2011 Recruitment Activities

During the period from February 1, 2010 through January 31, 2011, the unit had three full-time job openings which were filled as a result of radio advertising and the Unit's annual Job Fair.

2010-2011 Outreach Activities

The unit hosted a Job Fair on August 11, 2010 at the Hampton Inn, Utica, New York. Station personnel attending this Job Fair were Grant Roser, Sales Manager. Seven people attended this event and one salesperson was hired.

The unit also hosted an "Open House-Career Day" on August 25, 2010. Despite considerable promotion and advertising, one person attended.

During this employment period, Roxanne Roser, a senior manager of RCN stations, continued review of the book, EEO Law and Personnel by Arthur Gutman in order to provide training to ensure equal employment opportunity and discrimination prevention.

During the period, the unit continued its Internship Program which was initiated in October, 2007. During this past year, students from SUNY Oneonta, Hamilton College, Utica College, Mohawk Valley Community College, Whitesboro High School and Herkimer County Community College participated in the program. The purpose of the program was to introduce students to career opportunities in radio broadcasting.
